### **League Coordination, Shannon**

- 2021 Leagues look to be more normal than 2020.
- Biggest thing is that 18+ and 40+ will still have flight playoffs before going to districts and will advance; however, if we don't have as many teams, that could still be debatable.
- Trio is gearing up and deadline to register is Feb 26 for a minimum of 5 people.
- There are no team numbers available yet, and reservations will not be taken until Feb 1.
- Mixed league registration is Mar 5; 18+ is March 12<sup>th</sup>.
- Big changes at the upper levels; 5.0 players are no longer allowed in the 4.0/4.5 leagues. At this time, we may have one women's 4.5 team at the 18+ level. Shannon will notify the captain.
- Courts will be the same price this year as last (per Holly Carlson). Shannon will check to see if we are able to have all six courts. Both Morse and Daniels Park have the same court fees.
- At this time, there is no league coordinator's meeting scheduled. Colorado Tennis Association (CTA) may upload videos, but it does appear that all information is already on the website.
- LTA is lucky that we're in Jefferson county due to more relaxed COVID standards compared to other counties such as Denver.
- At this time, we are s till missing captains for Men's Leagues (18+ and 40+). Shannon will notify the board if anyone requests a Team number.
- It is anticipated that Lakewood Park courts may be resurfaced, which would reduce their team/league capacity. LTA will accept any teams from Lakewood Park or LTA based on a first-come, first-served basis. Karen Noreyko has already been contacted by one 3.0 Team from Lakewood Park interested in playing with LTA.
